

SERTY's WEEE categories and fees as of 1 January 2024

Recycling fees will be reported as net weight of the weight, excluding lamps* and fire alarms*, which are reported by number of units. Weight will be reported as net weight, without packaging, manuals or additional parts not covered by the WEEE Directive.

Remote control units, chargers and television and other display stands are included in the equipment, except when imported and sold as separate devices.

Any batteries, rechargeable or not, are covered by separate producer responsibilities (Recser Oy), and they are not included in the reported product weight.

The prices listed are excluding VAT and are the same for B2C and B2B devices.
